- 1) Dr. Charles Miller, President, convened the meeting at approximately 1:00 p.m.
- 2) Dr. Charles Miller asked for a motion to accept the minutes from the last meeting. Melanie Collins made the official motion to accept the minutes from the last business meeting. - 3) Financial Report

A question was asked if there is any money left over in the account and what is done with it. Greg stated that the account has plenty of money left over and he would have to give a more definite amount after he receives all funds from the conference. Additionally, a member questioned whether LAIR offers academic scholarships. The census was that it was done in the past, but not for the last few years. Members were unsure of the time scholarships were given. Dr. Miller suggested that the aforementioned questions should be advanced to the executive team.

4) Election of new officers:

The Vice President (Sheila DeRouen) moves up to the President position per LAIR by-laws. The Secretary and Treasurer are two-year appointments; as a result, Brian Keith Phillips will keep the office of Secretary and Greg Ohlenforst will keep the office of Treasurer. They were elected in the 2018 LAIR meeting as a result they will serve until the 2019 LAIR meeting.

There were two individuals nominated to serve in the position of vice president. Bernie K. Braun nominated Dr. Claire Norris from the University of Louisiana System. Ingrid Plain Cook nominated Ada Kwanbanbumpen for the position of vice president. No other nominations were given. A runoff was held 17 members voted for Dr. Claire Norris and 13 members voted for Ada Kwanbanbumpen, making Dr. Claire Norris the new vice president of LAIR for the 2018-2019 year. Dr. Charles Miller congratulated Dr. Claire Norris on her new position.
